# **OASL Waiver Agreement**

## **Definitions**

**OASL**. Olean Adult Soccer League, an informal group of people who play and/or organize pickup soccer games and league games.

**Releasees**. OASL, organizers, officers, directors, agents, employees, volunteers, insurers and representatives, facilities providers, field providers.

Facilities. Any and all fields, equipment, services, premises used for games & activities.

## Agreement

I understand that it's the responsibility of each player to play courteously and keep the game safe so no one gets injured. I assume all risks involved in playing, and hold "Releasees", organizers, field providers, and other parties involved harmless, and waive any and all rights, claims, or causes of action of any kind arising out of my participation in this Activity.

## **Assumption of Risk**

I acknowledge and agree that any use of the "Facilities", and participation in OASL activities ("Programs") comes with inherent risks including, but in no way limited to (1) moderate and severe personal injury, (2) property damage, (3) disability, (4) death, and (5) sickness or disease including, without limitation, COVID-19. I voluntarily accept and assume full responsibility for these risks as well as any and all other risks of the use Facilities and participation in Programs. I agree that I have full knowledge of the nature and extent of all such risks and am not required on all such risks being described in this document.

#### Waiver, Release, Indemnification, & Covenant Not to Sue

In consideration of the use of Facilities and participation in Programs, I, the undersigned, agree that the "Releasees" will not be liable for any personal injury, property damage, disability, death, sickness or disease incurred by myself, my family member, dependents, or guests, however occurring including, but not limited to negligence of Releasees. I understand that I will be solely responsible for any loss or damage, including personal injury, property damage, disability, death, sickness or disease sustained from the use of Facilities or participation in Programs.
